

Privacy Policy

Original Media, LLC ("Original Media", "we", "us", or "our") owns and operates the website located at www.comicbookmencasting.com (the "Site"). Original Media has created this Privacy Policy to let you know what information we may collect from you on the Site and how we may use that information. Please take a moment to review the terms of our Privacy Policy. By using the Site, you agree to accept the terms of our Privacy Policy. If you do not agree to the terms of this Privacy Policy, please do not use the Site. This Privacy Policy applies information collected on the Site. It does not apply to information that we may collect by means other than on the Site.

1. INFORMATION WE COLLECT ON THE SITE.

When you complete the Casting Questionnaire, you may be asked to provide us with information that may be used to identify you personally, such as your name, date of birth, age, address, including zip code, email address, phone number, and demographic information such as gender and occupation ("Personal Information"). We may also ask you to provide information regarding the item you are looking to buy and sell and any related photographs or other materials (together, with the Personal Information, your "Submissions").

2. HOW WE USE THE INFORMATION WE COLLECT.

We may retain and use your Submissions for the purpose for which they were submitted, including evaluating your application to appear on the Series. We may also use your Submissions, including your name, likeness, photos, and Casting Questionnaire responses, for advertising, publicity, promotion and other commercial purposes in connection with the television series entitled "Comic Book Men" (the "Series"), as well as any other purposes permitted by the "Release and Waiver" section of the Casting Questionnaire. We may use your email address to communicate with you. We may also use your Submissions to ensure compliance with our policies and applicable law.

3. DISCLOSURE OF PERSONAL INFORMATION.

We may share your Submissions with AMC Network Entertainment LLC ("AMC"), the network that distributes the Series, and any other licensees or assignees of any rights in the Series (and those licensees and assignees will have the same rights to use your Submissions that we have). We may also share your Submissions as disclosed at the time you provide your information, as set forth in this Privacy Policy and in the following circumstances:

Third Parties Providing Services On Our Behalf. We may share your Submissions with third parties that perform functions on our behalf such as service providers that host or operate the Site or administer the casting process for the Series. We may share your Submissions with these third-party providers so that they can perform their services.

Legal Disclosure. We may transfer and disclose your Submissions to third parties to comply with a legal obligation; when we believe in good faith that the law or a governmental authority requires it; to verify or enforce the Site's policies; to address fraud, security or technical issues; to respond to an emergency; to identify, contact or bring legal action against someone who may be causing injury to or interference with (either intentionally or unintentionally) Original Media's rights or property, other visitors, or anyone else that could be harmed by such activities.

Business Transfers. We may share your Submissions with other entities and our affiliates primarily for business and operational purposes. In the event that Original Media is involved in a bankruptcy, merger, acquisition, reorganization or sale of assets, your information may be sold or transferred as part of that transaction, subject to the terms herein.

4. YOUR PRIVACY RIGHTS, CHOICE AND ACCESS.

We are under no obligation to store your Submissions indefinitely and disclaim any liability arising out of, or related to, the destruction of such information. It may not always be possible to completely remove or delete all of your Submissions from our databases without some residual data because of backups and other reasons. We will retain and use your Submissions as necessary to comply with our legal obligations, resolve disputes, and enforce our policies.
